

## Compliance with the Corporate Governance Code

The discussions on corporate governance in the Netherlands resulted in the first Dutch Corporate Governance Code which became effective as of 1 January 2004. This code was updated in 2009 and again in December 2016. Dutch listed companies are to report on their application of the Code and to explain any deviations from its best-practice provisions.

In this overview you will find the full text of the Dutch Corporate Governance Code – consisting of the principles and related best-practice provisions – and the way Royal BAM Group applies these as per 31 December 2018.

As explained in the Annual Report 2018, BAM's corporate governance structure will change in 2019 to accelerate the execution of the 2016-2020 Strategic Agenda 'Building the present, creating the future'. The consequences on the compliance with the Code will be explained in the overview per 31 December 2019. Please note: At BAM, the Management Board as referred to in the Corporate Governance Code is called Executive Board. The company currently also has a Management Board, but this body is not to be considered as an executive committee, given that it is not closely involved in the decision-making of the Executive Board. In the course of 2019 an Executive Committee will be established, for which the related best practice principles of the Code will apply.
